### What Does Ravenwood Capital Management, LLC DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect, and share depend on the product or service you have with us. This information can include:

- Social Security number and Investor Profile
- Account Numbers and Account Names
- Account Balances and Transaction Details

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### How?

All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Ravenwood Capital Management, LLC chooses to share; and whether you can limit this sharing.

## What we do

### How does Ravenwood Capital Management, LLC protect my personal information?

### How does Ravenwood Capital Management, LLC collect my personal information?

We collect your personal information, for example, when you

- Open an account or Provide your investment profile
- Provide custodian info or Provide DTC Settlement Instructions
- Complete an Investment Management Agreement

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

## Definitions

### Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- **Ravenwood Capital Management, LLC is not affiliated with any other entity.**

### Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- **Ravenwood Capital Management, LLC does not share with non-affiliates, so they can market to you.**

### Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- **Ravenwood Capital Management, LLC does not market jointly.**

## Other important information
